| JOB DESCRIPTION & RESPONSIBILITIES:

Director (Infrastructure) is a member of Board of Directors and has the overall responsibility of delivering Western DFC as per time bound program and completing various activities viz. procurement of works, contract administration, project procurement, coordination with various State Governments, Ministries and other public authorities. Dir. (Infra) is also involved in the planning of new corridors, DPRs and land acquisition for the existing and future lines.
- 2. **Pay Scale:** Rs.75,000-1 ,00,000/- (IDA Pre-revised)
