Delhi Metro Rail Corporation (DMRC), a Government owned company, has been set up for implementation and operation of the rail-based Mass Rapid Transit System in Delhi. The company intends to appoint the following official:

Date of Vacancy (DOV): **01.12.2021**

Scale of the Post: Rs.180000 - 340000 (IDA) and other allowances/perks/privilege.

Duration of Appointment: The appointment will be on a contract basis presently, for a period of

5 years, or, the date of superannuation, whichever is earlier

1. Job Description and Responsibilities

The incumbent of the above post shall be a member of the Board of Directors of DMRC and will report to the Managing Director of the company.

He shall be responsible for operations, commercials, safety and security of the Metro Sections opened for revenue services. He will closely associate with the Project Wing for planning of the new metro lines. He will also be responsible for maximizing revenue through Fare Box Collections and Non-Fare Box, viz, Advertisements and Property Business, etc. In addition, he shall look after the functioning of the Delhi Metro Rail Academy (DMRA).

1. The applicant should have at least ten (10) years' experience in operation of major rail-based urban Transportation system.

Desirable:

1. Experience of operation and development of Modern urban rail-based Transportation system.

a. Public Sector Executives in the pay scale of Rs. 120000 – 280000 (Revised), or, Rs. 51300-73000 (Pre-revised IDA), or, higher.
